WHEREAS, the Authority's Auditors, Suplee, Clooney & Company, in the Audit for the 2015 year end certified that the Authority yielded net surplus in excess of \$465,000 from the 2015 fiscal year and have recognized that the Authority has \$4.3 million of unrestricted surplus at December 31, 2015; and

WHEREAS, by Resolution #34-16, the Board authorized that \$300,000 of 2015 surplus be transferred from US Bank General Account #2574000645 to a newly created US Bank account to be named, 'Reserve for Chapter 88 Retiree Benefits'; and
